## Policy, Finance and Performance Management Committee, 7<sup>th</sup> September 2022 Item 3)

## 1. Background

This committee considered potential changes to the Town Council's committee structure at its meeting on 11<sup>th</sup> May 2022. It was noted that the Town Council's existing committee structure was adopted in May 2007 and amended in July 2015 with the creation of the Planning & Consultation Committee and addition of policy matters to the remit of the Finance & Performance Management Committee.

Whilst the proposed alignment of committees with corporate objectives was broadly supported, significant concern was raised regarding the potential disbandment of the Roads and Transport Committee and the loss of clarity for local residents over which committee would address their concerns over parking and traffic management. A potential means of addressing this concern is set out below.

## 2. Overview of amended proposal for revised committee structure

The core of the revised committee structure that was considered in May remains the same in this proposal, although some name changes are set out below:

- Tourism and Local Economy Committee addition of word 'Local' to bring clarity to economic role of this committee.
- Environment and Green Spaces Committee addition of 'Green Spaces' to make clear that management of parks, gardens and informal green space falls within the remit of this committee.
- Community Services, Health & Wellbeing Committee
- Planning, Consultation and Heritage Committee retention of consultation within the remit of this committee.
- Finance and Governance Committee
- Personnel Committee

It is proposed that the core role of the Roads and Transport Committee should be transferred to a Traffic Management Advisory Committee which would report to the Planning, Consultation and Heritage Committee. The Advisory Committee's role would be to make recommendations to its parent committee regarding potential changes to on-street parking and other traffic management measures, such as pedestrian crossings or one-way schemes. The Advisory Committee would also oversee the Town Council's input into the parking review that has been promised by Dorset Council.

One key advantage to this arrangement is that it could hold more frequent, shorter meetings, when necessary, as its parent committee will meet on a monthly basis to consider its recommendations. The minutes can also follow a standard format, simply recording the recommendation and a summary of the reasons behind the Advisory Committee's decision.

An amended structure chart for the revised committee structure is attached at the end of this briefing note.

If these proposals were to be agreed, it is proposed that the revised committee structure be reviewed by this Committee in April 2023, prior to the next annual Council meeting in May.

## 3. Detail of proposed revised committee structure

Set out below is a summary of the role of each committee which, if approved, will form the basis of Terms of Reference. It also sets out the key outside representatives and the relationship with the Council's working parties and advisory committees. The Committees ate listed in alphabetical order.
