

Amendments to Scale of Fees and Charges 2022/23

Each year the Council's standing committees consider relevant sections from the scale of fees and charges and make a recommendation to the Policy, Finance and Performance Management Committee prior to consideration by Full Council. The Council approved the fees and charges for 2022/23 at its meeting held on 17th January 2022.

Since that meeting, a number of anomalies have been identified between the recommendations made by the Committees and the fees and charges that were presented to this committee/Full Council. These relate principally to the Advertising Boards, Artisans on the Beach and charges for interments of cremated remains at Godlingston Cemetery. These were approved without the increase that was applied to other fees and charges in these sections. It is proposed that the cemetery charges and those for Artisans on the Beach be increased accordingly. However, it is suggested that the advertising boards charge should be frozen, in line with what was agreed in January, as customers have already been informed that the charge will not increase.

Two new charges are also proposed, in relation to a boat park season ticket and Artisans at the Market. All of the proposed amendments are set out in the table below.
