They were anxious to retain the tradition of a Punch and Judy Show, and it was AGREED:-

That the Town Clerk pursue options for the retention of a Punch and Judy Show on Swanage Beach.

The new Award allowed members of the public, as well as Dorset Police staff and officers, to nominate young people who had made a positive contribution to their community.
